2011-12 ANNUAL MEETING, JULY 5, 2012, ARS FESTIVAL, PORTLAND, OR

American Recorder Society President **Lisette Kielson** read the 2011-12 Annual Report at the Annual Membership Meeting on July 5, 2012. The meeting was presented as part of the ARS 2012 Festival in Portland, OR, with 75 people attending from over 19 states and from Canada, Bermuda, Brazil and Germany.

Lisette reported on yearly accomplishments such as publishing *American Recorder* magazine, awarding scholarships and grants, holding Play-the-Recorder Month activities, welcoming ARS Chapters and Consorts to the organization, working on the web site, sending out fundraising appeals, holding two Board meetings, and more.

She also mentioned special activities not held regularly such as elections for the ARS Board of Directors, presenting the ARS 2012 Festival, presenting the Presidential Special Honor Award, updating the Director and Officer job descriptions, having representation at the Berkeley (CA) Festival (Tish Berlin) and American Orff Schulwerk Association Conference (Nina Stern), and moving the ARS office, among others.

The report included the reading of a financial statement prepared by Treasurer Ann Stickney: This fiscal year has been encouraging. The membership numbers have remained fairly stable, and we are encouraged by the good support from donors even in these rough economic times. The Board continues to work hard at keeping our expenses in line while continuing to maintain important programs.

Harris, Ruth N., Boise, ID. Died 7/13/2012 at age 86. She grew up on a farm in Bedford, PA. The family moved to Detroit and Ruth was the first of her family to attend college. It is meant to provide aid for one-time chapter projects or "seed money" for projects that the chapter might continue to finance by other means. Grants are usually up to \$300. Preference is given for projects that:

- Show promise of increasing local and national membership
- Reach new audiences leading to greater diversity in ARS membership
- Provide special services (for example, to the elderly, to school children, to beginners, to the visually impaired, to the sick and disabled, to the economically impaired, etc.)
 Grants are not made for workshops.
 Grant applications are due each year

on **November 15** for projects starting at any time after the following January 1.
